AGENDA HEADING:

Approving Amendment No. 3 to Operating Contract between the WRA and the City of Des Moines to address insurance matters.

SYNOPSIS:

To amend the Operating Agreement pertaining to WRA Insurance and Risk Share Policies to allow, where possible, WRA to have separate insurance policies/programs from the City of Des Moines effective July 1, 2012.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

On September 20, 2011 the WRA Board requested legal counsel to draft an amendment to the Operating Agreement pertaining to WRA Insurance and Risk Share Policies to allow, where possible, WRA to have separate insurance policies/programs from the City of Des Moines effective July 1, 2012.

The Amendment to the Operating Agreement allows the WRA to retain insurance advisory and broker services to market insurance coverage for the WRA, except for Workers Compensation Insurance and Crime Insurance, and pollution liability insurance for underground fuel storage tanks which the Operating Contractor will purchase on behalf of the WRA.

The City, under the Operating Agreement, will continue to provide Risk Management Services to the WRA as part of the Operating Contractor's overall Risk Management Program to protect the WRA.
