AGENDA HEADING:

Hold hearing on grant of a license to the Greater Des Moines Public Art Foundation for the installation, display, and maintenance of five sculptures at the Hub Spot.

SYNOPSIS:

Recommend approval of agreement with the Greater Des Moines Public Art Foundation to install and maintain Jun Kaneko's Dangos sculptures in the Principal Riverwalk at the Hub Spot.

FISCAL IMPACT:

Amount: No financial impact to the city.

<u>Funding Source</u>: The Greater Des Moines Public Art Foundation is responsible for the installation and maintenance of the sculptures.

ADDITIONAL INFORMATION:

The Greater Des Moines Public Art Foundation has purchased five large ceramic sculptures titled "Dangos" to place on the Principal Riverwalk within the block north of Court Avenue, within the plaza area adjacent to the Kiosk building. The proposed placement of the Dangos has been presented to and approved by the Riverfront Development Authority, Urban Design Review Board, Park and Recreation Board and Access Advisory Board. The Greater Des Moines Public Art Foundation has coordinated the placement and necessary design modifications to allow the Dangos to be placed. The Greater Des Moines Public Art Foundation has provided design drawings for the lighting, foundations and pedestals associated with the art installation. Work will be coordinated with the Corps of Engineer and their contractor.

The Corps of Engineers is currently constructing the Court Avenue Plaza and Kiosk building, now known as the Hub Spot, and the trail connection along the west side, north of Grand Avenue using Corps of Engineers Greenbelt funding. The Greater Des Moines Public Art Foundation is responsible for all costs associated with the installation and maintenance of the Dangos.
