SYNOPSIS:

On May 8, 2006, Eastgate Plaza, L.L.C. provided a mortgage to the City of Des Moines for property located at 1530 East Euclid Avenue. The legal description on the mortgage mistakenly included a portion of the property that had been conveyed by warranty deed in January 2000 to LADCO Properties IV, L.L.C. A partial release of the City's mortgage is necessary to correct the legal description of the City's mortgage and to clear the title of the property conveyed to LADCO Properties, IV, LLC in 2000 prior to the 2006 city mortgage.
