AGENDA HEADING:

Set public hearing for the proposed amendment to the Second (2011) Year Action Plan of the 2010-2014 U.S. Department of Housing and Urban Development (HUD) Consolidated Plan.

SYNOPSIS:

This action sets the date of a public hearing to amend the Second (2011) Year Action Plan of the 2010-2014 HUD Consolidated Plan as a result of a second allocation of federal entitlement Emergency Solution Grant (ESG) funding.

FISCAL IMPACT:

Amount: \$105,703 Emergency Solutions Grant program funds for 2011 program year.

Funding Source: U.S. Department of Housing and Urban Development

ADDITIONAL INFORMATION:

On December 5, 2011 HUD published the interim rule for the amended Emergency Solution Grant (ESG) program along with corresponding amendments to the Consolidated Plan regulations. The interim rule became effective on January 4, 2012. Some of the PY2011 ESG funds were held in reserve by HUD for distribution after publication of the interim rule in order to implement the new program guidelines. Entitlement cities will receive the additional allocation only after their Consolidated Plans are amended and approved by HUD.

The amendments must be received by HUD by May 15, 2012, with a 30 days public comment period prior to approval and submission to the HUD regional office. Because of the extremely tight deadlines, the amendment will be available for public comment by April 5, 2012.

The Des Moines 2011 ESG amendment will be presented to the Neighborhood Revitalization Board at their meeting on April 4, 2012, for recommendation to the City Council. The City Council will be asked to approve the amendments at the Public Hearing scheduled for May 7, 2012.
