### **AGENDA HEADING:**

Hold hearing for vacation and conveyance of portions of SE 19th Street right-of-way between East Market Street and Scott Avenue to Waste Management of Iowa, Inc. for \$43,845 and to Kemin Holdings, LC for \$35,508.

#### **SYNOPSIS:**

Recommend approval for vacation and conveyance of portions of SE 19th Street right-of-way between East Market Street and Scott Avenue to Waste Management of Iowa, Inc., Jeff M. Harris, President, 1001 Fannin, Suite 4001, Houston, Texas 77002 for \$43,845 and to Kemin Holdings, LC, Dr. Christopher Nelson, President, 2100 Maury Street, Des Moines, Iowa 50317 for \$35,508. This action is required by Iowa law prior to making a final determination on the proposed sale by resolution. There is no current or anticipated public need for this property, except for the easements identified below. The sale of these portions of SE 19th Street will help minimize the impacts to Waste Management of Iowa, Inc. and Kemin Holdings, LC from the City's partial acquisitions of their property for the SE Connector Project.

# **FISCAL IMPACT:**

Amount: \$79,353 (Total Revenue)

Funding Source: Sale proceeds will be deposited into the following account: 2012-13 CIP, Street Improvements - Page 36, SE Connector – SE 14th Street to SE 30th Street, STR 249.


#### ADDITIONAL INFORMATION:

On February 27, 2012, by Roll Call No. 12-0277, the City Council received the recommendation from the Plan and Zoning Commission to vacate SE 19th Street from a point approximately 97 feet south of Raccoon Street to Scott Avenue, and Southeast 19th Street from East Market Street to a point approximately 78 feet north of Raccoon Street, be vacated and conveyed to Waste Management of Iowa, Inc. and Kemin Holdings, LC, subject to reservation of easements for all public utilities in place and a provision of an access easement for Midwest Sprinkler at 1900 Scott Avenue, until such time that access to Scott Avenue via SE 19th Street is not necessary.

Waste Management of Iowa, Inc. is the owner of the property locally known as 201 SE 18th Street abutting SE 19th Street right-of-way and has offered to the City of Des Moines the purchase price of \$43,845.00 for the vacation and conveyance of a portion of such right-of-way for the purpose of redevelopment with its adjoining property, subject to reservation of easement for public utilities, which price reflects the fair market value of the property based on independent appraisals obtained by the City's Real Estate Division.

Kemin Holdings, LC is the owner of the property identified as Polk County GeoParcel 7824-02-452-005 abutting SE 19th Street right-of-way and has offered to the City of Des Moines the purchase price of \$35,508.00 for the vacation and conveyance of a portion of such right-of-way for the purpose of redevelopment with its adjoining property, subject to the Plan and Zoning Commission recommendations, which price reflects the fair market value of the property based on independent appraisals obtained by the City's Real Estate Division.

The City of Des Moines has negotiated with Waste Management of Iowa, Inc. and Kemin Holdings, LC, to acquire portions of each of their properties needed for the SE Connector Project, subject to the sale of the above referenced portions of SE 19th Street. The sale of these portions of SE 19th Street will allow Waste Management of Iowa, Inc. to replace parking spaces lost due to the SE Connector Project and will allow Kemin Holdings, LC to assemble and incorporate the property into their new corporate headquarters development.
