## **AGENDA HEADING:**

Approving a renewal addendum to a contract for custodial services for the Fleet Services Center.

### **SYNOPSIS:**

Recommend approval of a renewal addendum to a contract for custodial services for the Fleet Services Center with Marsden Building Maintenance, LLC, 2801 Bell Avenue, Des Moines, Iowa, 50321, Chad Cordaro, Branch Manager in the amount of \$5,928.00.

### ADDITIONAL INFORMATION:

The original contract for custodial services for the Fleet Services Center was a result of a City wide RFP process in 2009. The original contract was for three years and expired on April 1, 2012. Marsden Building Maintenance requested a \$255.00 increase or \$5,928.00 total annual cost to renew the contract. In 2009, the second highest scoring respondent to the RFP for custodial services for the Fleet Services Center proposed a cost of \$9,122.04; therefore, it is recommended to renew with Marsden Building Maintenance and not rebid for these services.
