AGENDA HEADING:

Hold public hearing on a municipal lease for the purchase of nine dump trucks, an asphalt paver, and a compact motor grader for the Public Works Department.

SYNOPSIS:

Recommend approval of lease-purchasing of nine dump trucks, an asphalt paver, and a compact motor grader for the Public Works Department. This action initiates the financing process for this equipment acquisition.

FISCAL IMPACT:

Amount: Not to exceed \$2,000,000, plus interest

Funding Source: FY 2012 Operating Budget, Debt Service Fund, DS001, FIN900100, page 119

ADDITIONAL INFORMATION:

The City utilizes the lease-purchase program from time to time to finance vehicles and equipment as a means to avoid large one-time cash expenditures. Recently, the City utilized the master lease agreement to purchase vactor trucks for the Sanitary Sewer Enterprise. These replacement trucks, asphalt paver, and compact motor grader represent the large vehicle needs for the next 18 months with the next group of lease-purchased trucks expected early in 2014. Smaller vehicles will be purchased on a pay-as-you-go basis with available budgeted cash.
