#### **AGENDA HEADING:**

Approving and authorizing the execution of Iowa Department of Transportation Agreement for Grand Avenue over Walnut Creek Bridge Replacement.

### **SYNOPSIS:**

Recommend approval of Iowa Department of Transportation Agreement No. 1-12-SBRU-012 for County and City Bridge Construction Funds

#### **FISCAL IMPACT:**

Amount: \$3,316,610.69 (Construction Contract)

<u>Funding Source</u>: 2012-2013 CIP, Page Bridge-11, Grand Avenue over Walnut Creek, BRV045, being: City Bridge Construction funds for 80% of construction costs with a \$1,000,000 maximum; \$1,600,000 G.O. Bonds issued, \$200,000 G.O. Bonds to be issued, and the remaining \$516,610.69 in Gaming Monies (including a transfer of \$216,610.69 in gaming funds from BRV039).

### ADDITIONAL INFORMATION:

On March 24, 2008, under Roll Call No. 08-463, the City Council approved an agreement with the Iowa Department of Transportation (IDOT) for \$1,000,000 of Federal Highway Bridge Program Funds. In accordance with the approved agreement, IDOT received and opened bids on March 20, 2012. On April 9, 2012, City Council held the public hearing and entered into a construction contract with Jenco Construction Inc., Herluf H.S. Jensen, President, 6804 NW 2nd Street, Des Moines, Iowa, 50313.

IDOT has subsequently made state funding available in place of the Federal Highway Bridge Program funds. This agreement supersedes the previous agreement. The funding amounts are the same. State City Bridge Construction Funds are available for 80% of the eligible project costs up to a maximum of \$1,000,000. This change is administrative. All the contract requirements included in the project bid documents remain the same, including compliance with Davis Bacon. This will remove the federal audit requirements that are normally associated with federally funded projects.
