Approving Change Order No. 14 with Dean Snyder Construction Company for additional work on the Fire Training & Logistics Facility project, for a total not to exceed \$27,654.93.

SYNOPSIS:

Recommend approval of Change Order No. 14 in an amount not to exceed \$27,654.93 with Dean Snyder Construction Co., Don Snyder, President, 5151 SE Rio Court, Ankeny, Iowa 50021, for additional work on the Fire Logistics and Training Facility to provide wireless access points on the interior and exterior of the building.

ADDITIONAL INFORMATION:

The contract for the construction of the Fire Department Training and Logistics Facility was awarded to Dean Snyder Construction Company in the amount of \$8,130,000 on February 28, 2011. Wireless Access points were not included in the base bid documents, as the required equipment could have been acquired as part of a larger wireless installation effort. Since the facility will be operational in late summer, it is now more advantageous to include two exterior and twelve interior access locations in the construction contract. The exterior access points will also allow other public safety vehicles to download and upload data during patrols.
