**AGENDA HEADING:**

Approval of Methamphetamine Drug Hot Spots Grant Program FY10 Award increase and extension.

**SYNOPSIS:**

Recommend approval of the increased funding and grant extension for the Methamphetamine Drug Hot Spots Grant Program FY10 Award. The Police Department was originally awarded \$31,576 to be expended by or before December 2011. An additional \$18,424 was awarded in January 2012 which extended the closing date to June 2012. The Police Department was recently notified by the Iowa Office of Drug Control Policy that additional funds were available upon request. The Police Department submitted a written request to increase the total award to \$62,700 and extending the closing date of the grant to December 30, 2012. This grant does not have a match contingency.

**FISCAL IMPACT:**

Amount: Additional \$ 12,700, to increase total award to \$ 62,700.

Funding Source: Operating Budget: SP751 POL985015 Page 249 of the Recommended Budget for FY13.

**ADDITIONAL INFORMATION:**

The Iowa Office of Drug Control Policy (IODCP) contacted the Police Department regarding available funding for activities associated with methamphetamine drug interdiction within the city limits of Des Moines. The Police Department originally applied for the funding in July of 2010 and Council approved the acceptance of the original award in the amount of \$31,576 in October 2010. Since accepting the initial award, the Police Department has been offered further funding from IODCP to continue the initiative increasing the total of the awarded amount to \$ 62,700. With each additional increase, the closing date of the grant was extended by six (6) months. The grant originally expired in December 2011, however; the recent increase would extend the grant period to December 2012.
