AGENDA HEADING:

Public hearing regarding request to rezone property in the vicinity of 1540 Scott Avenue from "M-2" Heavy Industrial District to "PUD" Planned Unit Development and the "City of Des Moines Municipal Services Center PUD Conceptual Plan" to allow the initial phase of development of a municipal services campus with approximately 85,000-square foot facility for offices, shops, and storage; and a 50,000-square foot outdoor storage yard for combined functions of the Parks and Recreation, Public Works, and Engineering Departments of the City.

SYNOPSIS:

On May 17, 2012, the Plan & Zoning Commission voted 11-0, to recommend approval of a rezoning to "PUD" Planned Unit Development and approval of a "PUD" Conceptual Plan for the City's Municipal Services Center in the vicinity of 1540 Scott Avenue. Following the Plan & Zoning Commission's public hearing, a revised "PUD" Conceptual Plan has been submitted for consideration by City Council. The two differences between the Conceptual Plan reviewed by the Plan & Zoning Commission and the Conceptual Plan reviewed City Council are as follows:

- 1. Provision of a note to state that Small Wind Energy Conservation Systems shall be permitted in accordance with City Code Section 134-1280. No systems are currently proposed or shown on the Concept Plan.
- 2. The minimum required setback for structures would be 25 feet except for the northwest corner of the proposed building, which would have setback of zero (0) feet from the property line adjoining the Southeast Connector right-of-way. The reduced setback is necessary to accommodate a shift in the building and site improvements that minimizes impacts on the adjoining Burlington Northern Santa Fe railroad line. The impact of the reduced setback for the northwest corner of the building would be minimal since there will be approximately 70 feet of right-of-way between the travelled path of the Southeast Connector and the property line.

Staff recommends approval of the PUD Zoning and revised PUD Conceptual Plan.
