AGENDA HEADING:

Approving Supplemental Agreements to the Southeast Connector Professional Services Agreement with Kirkham Michael & Associates to provide additional design and construction phase services for the Southeast Connector projects.

SYNOPSIS:

Recommend approval of two Supplemental Agreements, No. 13 and 14 to the Professional Services Agreement with Kirkham Michael & Associates, Inc., Roger Helgoth, P.E., President, 12700 West Dodge Road, Omaha, Nebraska, for a cost plus fixed fee not to exceed \$86,570, to provide additional design and construction phase services for the Southeast Connector projects.

FISCAL IMPACT:

Amount: \$86,570

<u>Funding Source</u>: 2012-2013 CIP, Page Street-34, Southeast Connector - S.W. Second to S.E. Sixth Street, STR214, \$52,932 in Des Moines Tax Increment Bonds and 2012-2013 CIP, Page Street - 35, Southeast Connector - S.E. Sixth Street to S.E. 14th Street, STR219, \$33,638 in Des Moines Tax Increment Bonds.

ADDITIONAL INFORMATION:

Supplemental Agreement No. 13 includes, additional design services required to comply with current design standards and including at-grade rail crossings, while the Norfolk Southern Railroad evaluates abandonment and relocation the rail facility. Additional work includes, continued railroad coordination, revised roadway alignment for the at-grade rail crossings, modifications to bid quantities and cost estimates. While this portion of the project has been delayed pending resolution of the railroad agreement, the Iowa DOT requirements have changed. The plans will be updated to comply with DOT requirements for a construction letting in October 2012.

Supplemental Agreement No. 14 includes, the additional services required to provide construction administration and on-site observation of punch list items remaining from the construction of the Southeast Connector from SW 2nd to SE 6th Street. Continued services include, follow-up on additional punch list items, preparing paperwork for audit purposes, attending the audit meeting and preparing the final change order and pay estimate.

The Request for Proposal (RFP) and selection process included construction phase services, as part of the project. However, until design is completed and construction is planned, the scope of work to perform construction phase services on a project cannot be finalized. The need for future supplemental agreements for construction phase services on each construction project were noted when the original contract was approved. Professional Services has been funded primarily with Federal grant dollars.
