AGENDA HEADING:

Ordering construction of the following: 2012 Expanded Street Resurfacing Program - Contract 1 - Receiving bids, (7-10-12), and Setting date of hearing, (7-23-12). (Construction Estimate - \$1,100,000).

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the placement of hot mix asphalt (HMA) overlay on streets citywide to address citizen concerns regarding the condition of city streets by preserving deteriorating infrastructure and to improve the ride.

Funding Source: 2012-2013 CIP, Page Street - 40, Special City-wide Street Improvements, STR217, Being: Gaming Monies

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2012 Expanded Street Resurfacing Program - Contract 1, 06-2012-003. The improvement includes scarification of existing streets, furnish and place Hot Mix Asphalt (HMA), and other incidental items; all in accordance with the contract documents, including Plan File Nos. 546-66/80, at the following locations within the City of Des Moines, Iowa:

- E. 16th Street from Dean Avenue to Lyon Street
- 39th Street from Franklin Avenue to Hickman Road
- 40th Place from Adams Avenue to Amick Avenue
- 44th Street from Hickman Road to Urbandale Avenue
- 52nd Street from Urbandale Avenue to Douglas Avenue
- Center Street from 42nd Street to 800 feet west
- Douglas Avenue from 2nd Avenue to Cornell Street
- Franklin Avenue from M. L. King Jr. Parkway to 16th Street

Indianapolis Avenue from E. 37th Street to E. 41st Street
Walker Street from E. 15th Street to Dixon Street
Woodland Avenue from M. L. King Jr. Parkway to 15th Street.

The estimated construction cost is \$1,100,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
