## **ADDITIONAL INFORMATION:**

The Housing Services Department's Community Action Agency Division is charged with providing services to the City's low-income families and trying to address and eliminate causes of poverty. The Agency's residential furnace repair and replacement program will maintain safe heating systems in homes owned by qualified low-income families.

Originally ten (10) Requests for Proposals were mailed and the City received four (4) responses with Best Heating, Cooling and Electric, as the primary contractor to provide these services. Staff is recommending that the Housing Services Director be authorized to execute the fifth and final renewal for these services.

The beginnings of Community Action can be found in the signing of the federal Equal Opportunity Act in 1964. There are now over 1,000 Community Action Agencies in the U.S. and the City of Des Moines is one (1) of eighteen Community Action Agencies serving Iowa.
