#### **AGENDA HEADING:**

Ordering construction of the following: Municipal Service Center Preliminary Site Grading - Receiving bids, (8-28-12), and Setting date of hearing, (9-10-12). (Construction Estimate - \$2,287,245).

#### **SYNOPSIS:**

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. The City's service yards at S.E. 20th Street and Scott Avenue which house Public Works, Park and Recreation, and Engineering functions, will be displaced by the planned extension of the SE Connector. The City has also entered into development agreements with Kemin Industries for remaining portions of this site not required by the construction of the SE Connector. Phase 1 of the Municipal Services Center will provide the necessary replacement facilities. This project provides for preliminary site work including the installation of an intermediate foundation system, placement of the necessary fill for the building, and grading of the site, to allow construction of the Phase 1 building to begin in the spring of 2013.

### **FISCAL IMPACT:**

Amount: \$2,287,245, City Engineer's Estimate

Funding Source: 2012-2013 CIP, Page Building-10, Municipal Service Center, BLD124, TIF Bonds.

#### **ADDITIONAL INFORMATION:**

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Municipal Service Center Preliminary Site Grading, 10-2013-001. The improvement includes removal of existing paving and debris, clearing and grubbing, excavation, furnishing and placing earthen fill, intermediate foundation system, storm sewer, seeding, storm water pollution prevention plan, erosion and traffic control; all in accordance with the contract documents including Plan File Nos. 547-107/124, located at the future Municipal Services Center site, 1550 Scott Avenue, Des Moines, Iowa.

The estimated construction cost is \$2,287,245. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
