AGENDA HEADING:

Request vacation of Norfolk Southern Railway railroad crossings at East 1st Street, East 2nd Street, East 3rd Street, East 4th Street, East 5th Street, East 6th Street, SE 25th Court, and SE 26th Court.

SYNOPSIS:

Recommend request to vacate railroad crossings owned by Norfolk Southern Railway at East 1st Street, East 2nd Street, East 3rd Street, East 4th Street, East 5th Street, East 6th Street, SE 25th Court, and SE 26th Court.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

A series of actions to address railroad impacts associated with the Southeast Connector are required to allow construction of the project from SE 9th Street to SE 30th Street. In recent discussions with Norfolk Southern Railway and Burlington Northern Santa Fe Railway, a projected timeline of December 2012 was established to finalize agreements. This action to request vacation of Norfolk Southern Railway's current crossings of city streets, as suggested by Norfolk Southern Railway, will allow the railroad to file for abandonment with the Federal Surface Transportation Board of said crossings and the accompanying railroad tracks. After abandonment, this former railroad property is expected to be acquired by the City for the Southeast Connector project pursuant to a land exchange agreement with Norfolk Southern Railway that is currently being negotiated. Future Council actions will include consideration and approval of the property transactions and agreements for design and construction of railroad facilities. The schedule for construction of the Southeast Connector is directly tied to the completion of agreements with both Norfolk Southern and Burlington Northern Santa Fe.
