## **AGENDA HEADING:**

Ordering construction of the following: PCC Overlay - East 18th Street from East Walnut Street to Dean Avenue - Receiving bids, (9-11-12), and Setting date of hearing, (9-24-12). (Construction Estimate - \$134,500).

### **SYNOPSIS:**

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project will construct a Portland cement concrete overlay on East 18th Street between East Walnut Street and Dean Avenue and provide drainage and sidewalk ramp improvements, to preserve deteriorating infrastructure.

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the PCC Overlay - East 18th Street from East Walnut Street to Dean Avenue, 06-2012-005. The improvement includes construction of PCC pavement overlay, full depth PCC patching, sidewalk, storm sewer improvements and other incidental items; all in accordance with the contract documents, including Plan File Nos. 547-001/011, located on East 18th Street between East Walnut Street and Dean Avenue, Des Moines, Iowa.

The estimated construction cost is \$134,500. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
