AGENDA HEADING:

Approving a Memorandum of Understanding (MOU) with the Beaverdale Betterment Coalition (BBC) for the implementation of the Beaver Avenue Streetscape Project.

SYNOPSIS:

Recommend approval of the MOU with the BBC for the Beaver Avenue Streetscape Project. The purpose of the MOU is to establish a cooperative agreement between the City and the BBC to carry out the final design and implementation of the Beaver Avenue Streetscape Project.

FISCAL IMPACT:

Amount: \$420,000

Funding Source: 2012-2013 CIP, Page Street-41, STR231, Streetscape Improvements

ADDITIONAL INFORMATION:

For several years, the Beaverdale business district has been considering streetscape improvements for Beaver Avenue. The City of Des Moines along with the BBC and the Beaverdale Neighborhood Association (BNA) hired Genus Landscape Architects and Veenstra & Kimm Engineering to conduct a streetscape planning process. This planning process was very intensive and involved a stakeholder steering committee, online survey, as well as a series of public input meetings to refine the project proposal to ensure that the project will suit the needs and wants of the businesses, property owners, and surrounding neighborhood. The end result is a well defined concept plan for the area that is now ready for the next step of design and engineering.

The project will involve a number of funding sources, including public and private funding. The City of Des Moines has secured a number of grants to be utilized for the construction of this project. If for some reason any of the grant funds are reduced or eliminated prior to project construction, the City retains the right to reevaluate the project to consider reducing the project scope or terminating the project. Below is a breakdown of the estimated project cost and the anticipated funding sources:

Total Project Costs = \$2,500,000

Roundabout Costs: \$1,325,000 Streetscape Costs: \$1,175,000 Funding Breakdown:

Public Grant Funds = \$1,318,000 Anticipated Public Contribution = \$882,000 Anticipated Private Contribution = \$300,000

The General Guidelines for City Assisted Streetscape Projects, that were adopted by City Council on August 10, 2009, provide a roadmap to guide community stakeholders through a successful streetscape process. This document not only provides a step-by-step description of the process, but it also provides a framework for cost sharing requirements with public and private funding that is necessary to implement these enhancement projects.

A new step to the streetscape process is the drafting and signing of a MOU between the City and the business association that is requesting the streetscape improvements. The Beaver Avenue project is the first project to include an MOU but it is anticipated that this will be a requirement for future streetscape projects as well. The MOU builds upon the General Guidelines for City Assisted Streetscape Projects and formalizes many of the project details such as timeframe, roles and responsibilities, and fundraising expectations. This allows the City and the business district to understand and agree upon the necessary requirements to see the streetscape project through to completion.

The BBC is the organization that functions as the business association for the Beaver Avenue corridor. Because the BBC is representative of the businesses and property owners who will be directly affected and benefited by the project, it seemed appropriate that they be the one to sign the MOU. The BBC has reviewed this document with their board and have authorized Lexi Wornson, President of the BBC to sign the MOU on behalf of the BBC.
