# **AGENDA HEADING:**

Approval to purchase one hundred seventy two (172) portable radios and related equipment from Racom Communications, 201 West State Street, Marshalltown, Iowa, 50158, President and CEO, Michael Miller.

### SYNOPSIS:

The Des Moines Police Department is working in conjunction with the Polk County Sheriff's Office to establish a voice radio system with capabilities of working with surrounding area radio systems. The radios being purchased are an intricate part of the project. These radios would allow thirty (30) police, fire, and emergency management entities, throughout the Polk County area, to communicate with the City of Des Moines Police radio system.

# **ADDITIONAL INFORMATION:**

The Voice Radio Interoperability Project or Metropolitan Interoperability Communications System (MICS) began with the City of Des Moines receiving funding from the 2005 Community Oriented Policing Services (COPS) Interoperability grant. The project is nearing completion. This purchase will provide additional equipment necessary to expand the shared radio capabilities to several fire and police departments throughout Polk County. It also will promote and allow shared radio services between the City of Des Moines and the Polk County area.

The MICS Project will establish a system providing radio communication to be shared between the City of Des Moines and the entities within Polk County. This capability will assist first responders with information sharing in regards to emergency services.

Should future funding become available through the City of Des Moines project, we would be allowed to further invest in the MICS Project by purchasing additional radios for the Polk County area from remaining MICS grant funds. This purchase would be allowed under the approval of the procurement department.
