#### **AGENDA HEADING:**

Approval of Iowa Department of Commerce, Alcohol Beverage Division 28E Agreement, funding to support tobacco compliance checks on retailers for sale to minors.

# **SYNOPSIS:**

The Iowa Department of Commerce, Alcohol Beverage Division, has funding available to support a program to conduct one (1) compliance check on cigarette permit holders for compliance with prohibition on the sale of tobacco to minors during FY2013. The Vice and Narcotics Control Section of the Police Department will conduct these checks on tobacco retailers for payment from the Iowa Department of Commerce.

# **FISCAL IMPACT:**

<u>Amount</u>: It is estimated compliance checking at approximately 300 establishments for a total reimbursement of approximately \$15,000.

<u>Funding Source</u>: GE001 POL010700 Vice and Narcotics Control. The Operating Budget for Fiscal Year ending June 30, 2013, page 202.

### ADDITIONAL INFORMATION:

The Iowa Department of Commerce has received funds from the tobacco settlement to conduct checks on tobacco retailers for compliance with prohibitions on the sale of tobacco to minors.

The Vice and Narcotics Control Section of the Police Department will perform the work on completing the enforcement of this Program. The City has approximately 300 cigarette license permit holders. Random and unannounced compliance checks will be made on these permit holders.

The City will be paid \$50 for each compliance check. This is a continuation of previous efforts within the same program.
