AGENDA HEADING:

Requesting approval of a grant agreement between the Iowa Homeland Security and Emergency Management Division (HSEMD) and the City of Des Moines on behalf of Law Enforcement Intelligence Network (LEIN) 5 Intelligence and Information Sharing Office.

SYNOPSIS:

The Des Moines Police Department recommends approval of the Federal Fiscal Year (FFY) 2012 Iowa HSEMD grant agreement with the City of Des Moines serving as a sub-grantee on behalf of the LEIN region 5. The agreement names the City of Des Moines as the fiscal agent to perform a scope of work supporting Intelligence and Information Sharing center.

Amount: \$147,882.00

ADDITIONAL INFORMATION:

The LEIN Region 5 encompasses a 20 county area in south central Iowa. The focus of service is to disseminate accurate and timely intelligence and information to law enforcement, fire personnel, EMS, and private industry partners as it relates to threatening events. The continuation of collaborative information sharing is essential to the security of the State of Iowa. The intelligence is utilized to identify possible patterns of activity throughout the 20 county area to alert agencies and private industries of possible terrorist activity, criminal activity, and natural issues.

As the sub-grantee the City of Des Moines will utilize the funding to support the information sharing responsibility as stated in the scope of work which has been approved by the HSEMD grant coordinator. This grant does not require matching funds and has a grant period of October 1, 2012 to June 30, 2014.
