# **ADDITIONAL INFORMATION:**

Significant items in Neighborhood Development Corporation's proposed Bylaws Amendment include: 1. Increasing the number of directors from 12 to 15. This change was recommended to add two (2) at-large members, which will allow NDC to expand the development expertise on the board and to pursue representation from the immigrant communities NDC frequently serves. The director change also adds a third representative from the City of Des Moines.

2. The Amendment also eliminates Polk County's right to remove directors holding certain positions. This was a residual component of the original Bylaws. Polk County does not have an ongoing funding commitment with NDC.

The remaining amendments are considered minor and relate to date conflicts within the Bylaws.
