AGENDA HEADING:

Hold hearing on sale and conveyance of City-owned property at 2843 and 2839 Indianola Avenue to Hatch Development Group, L.L.C.

SYNOPSIS:

Recommend approval for the sale and conveyance of City-owned property at 2843 and 2839 Indianola Avenue to Hatch Development Group, L.L.C., Jack Hatch, Principal, 1312 Locust Street, Des Moines, Iowa, 50309. This action is required by Iowa law prior to making a final determination on the proposed sale by resolution. There is no current or future public need or benefit for this property.

ADDITIONAL INFORMATION:

On December 20, 2010, by Roll Call No. 10-2063, the City Council authorized acquisition of property at 2843 and 2839 Indianola Avenue as part of the Neighborhood Stabilization Program. This property adjoins property previously acquired by the City at 2800 and 2810 SE 8th Street known as Southern Meadows Apartments. The purpose of this purchase was to allow the City to enhance redevelopment opportunities of the Southern Meadows site.

On December 5, 2011, by Roll Call No. 11-2056, City Council authorized the City Manager to negotiate with Hatch Development Group, L.L.C. on a development agreement to redevelop the Southern Meadows site at 2800 SE 8th Street and adjoining parcels. On January 23, 2012, by Roll Call No. 12-0122, City Council approved the sale and conveyance of such property to Hatch Development Group, L.L.C. for a total price of \$43,400, subject to terms and conditions of the development agreement.

The City has since acquired the property at 2843 and 2839 Indianola Avenue. This property, along with a triangular piece of excess City-owned property adjoining 2839 Indianola Avenue, was intended to be included in the conveyance pursuant to the development agreement with Hatch Development Group, L.L.C.
