AGENDA HEADING:

Set date of public hearing on the proposed Fifth Amendment to the Urban Renewal Plan for the SE AgriBusiness Urban Renewal Area.

SYNOPSIS:

This roll call sets the date of public hearing on the proposed Fifth Amendment to the SE AgriBusiness Urban Renewal Plan for the February 25, 2013 City Council meeting. The proposed amendment updates the urban renewal plan with information, as required by state law, relating to the provision of tax increment financial assistance approved by the City Council for the Helena Industries and Kemin Industries projects.

FISCAL IMPACT:

<u>Amount</u>: There is no direct fiscal impact related to the approval of the Fifth Amendment. The public activities and projects that may be assisted by this urban renewal plan and tax increment revenues are now listed in the plan text.

Funding Source: Each project has a specific fund code assigned.

ADDITIONAL INFORMATION:

More specifically, the proposed amendment provides for:

- Approving financial assistance in the form of tax increment revenues from the SE Agribusiness Urban Renewal Area for the Kemin Industries expansion project in the vicinity of 2100 Maury Street and the Helena Industries expansion project in the vicinity of Vandalia Road and S.E. 36th Street and adds these two projects to the newly-added "Appendix A – Approved Economic and Redevelopment Activities."
- Supplements text relating to planning, administration and oversight.
- Updates the Financial Condition Report to reflect the approved projects and anticipated use of tax increment funds in the future.
