AGENDA HEADING:

Approving consent to collateral assignment of development agreement and estoppel agreement—Temple for Performing Arts (1011 Locust St.) rehabilitation project.

SYNOPSIS:

The City entered into a development agreement with several entities (Harry Bookey representing B.H. Temple, Inc., Downtown Preservation Partners, L.L.C. and The Temple Partners, L.P./400 Locust St., Des Moines) in 2002 for the renovation of the former Masonic Temple building at 1011 Locust Street. This agreement provided for an annual payment of \$31,000 subject to certain provisions of the agreement including requiring City approval of changes to the terms and conditions of the mortgages for the property. The developer has requested the City consent to the assignment of the Developer's annual payment as collateral for a new mortgage loan. The Office of Economic Development and City Legal have reviewed the collateral assignment and recommend approval.
