AGENDA HEADING:

SYNOPSIS:

Recommend approval of the Supplemental Agreement No. 1 to the Professional Services Agreement with Calhoun-Burns and Associates, Inc., Michael Vander Wert, President, 1500 30th Street, West Des Moines, Iowa 50266, for a total cost not to exceed \$30,560, based on hourly rates, to provide additional professional services for final design and construction administration for the Easter Lake Drive over Easter Lake Bridge Rehabilitation.

ADDITIONAL INFORMATION:

On July 13, 2009, by Roll Call No. 09-1190, the City Council approved professional services with Calhoun-Burns and Associates, Inc. for evaluation, design, and construction phase services for Easter Lake Drive over Easter Lake Bridge Rehabilitation. The design of the structure required relocation and coordination of the overhead utilities into underground conduits required additional design phase work. In addition, the one-year delay of the project start due to Indianola Road construction required adjustment to the 2013 hourly rate schedule for construction services. Supplemental Agreement No. 1 reflects the additional costs to complete final design and provide construction administration services.
