# **AGENDA HEADING:**

Ordering construction of the following: Gray's Lake Northwest Shoreline Retaining Wall - Receiving bids, (2-26-13), and Setting date of hearing, (3-11-13). (Construction Estimate - \$78,700).

### SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for protection of the shoreline of Gray's Lake near the entrance roadway to the beach area. There has been continuing erosion along this shoreline that is starting to impact the integrity of the entrance roadway. The sheet pile retaining wall will prevent any further erosion from occurring.

# **ADDITIONAL INFORMATION:**

This project serves to protect existing infrastructure within Gray's Lake Park. Years of flooding have eroded the shoreline up to the edge of the road. Without this project the road and underlying utilities would be at risk of failing during a future flood event. One of the major utilities under this road includes a major water main.

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Gray's Lake Northwest Shoreline Retaining Wall, 11-2013-003. The improvement includes installation of a sheet pile retaining wall and drainage system, and other incidental items; all work in accordance with the contract documents, including Plan File Nos. 549-007/012, at Gray's Lake Park in Des Moines, Iowa.

The estimated construction cost is \$78,700. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
