AGENDA HEADING:

Hold hearing for vacation and conveyance of the east 12 feet of East 33rd Street right-of-way from vacated Thompson Avenue to a point 282 feet to the north, to St. Joseph's Church of Des Moines, Polk County, Iowa for \$350.

SYNOPSIS:

Recommend approval of vacation and conveyance of the east 12 feet of East 33rd Street right-of-way from vacated Thompson Avenue to a point 282 feet to the north, to St. Joseph's Church of Des Moines, Polk County, Iowa, Bill Konnath, Business Manager, 3300 Easton Boulevard, Des Moines, Iowa, 50317, for \$350. This action is required by Iowa law, prior to making a final determination on the proposed vacation and sale by resolution. There is no current or anticipated public need for this property, except for the easement identified below. The sale of this property will help reduce the City's ownership of excess land.

FISCAL IMPACT:


Amount: \$350 (Revenue)

<u>Funding Source</u>: Sale proceeds will be deposited into the Property Maintenance Endowment Fund, SP767, ENG980500. The first \$175,000 of annual proceeds to the Property Maintenance Endowment Fund will be returned to the General Fund (GE001, ENG040700) to offset the operating budget of the Engineering – Real Estate Division.

ADDITIONAL INFORMATION:

St. Joseph's Church of Des Moines, Polk County, Iowa, the owner of 3300 Easton Boulevard, has offered to purchase the east 12 feet of East 33rd Street right-of-way adjoining their property for \$350 to allow for expansion and parking lot construction. The property to be conveyed consists of approximately 3,855 square feet, and the purchase price is equal to the estimated fair market value of the property as determined by the City's Real Estate Division.

The only anticipated current or future public need for this property is for public access over a portion of the property adjoining vacated Thompson Avenue, so the City's conveyance will be subject to a permanent easement for public access across the east 12 feet of vacated East 33rd Street lying west of and adjoining vacated Thompson Avenue.
