## **AGENDA HEADING:**

Approval to purchase systems furniture workstations, seating, filing cabinets, and bedside cabinets to be installed in Fire Station No. 1.

#### **SYNOPSIS:**

Recommend approval for the purchase of systems furniture workstations, seating, filing cabinets, and bedside cabinets to be installed in the new Fire Station No. 1. The furniture is needed to replace existing furniture that is no longer serviceable.

#### **FISCAL IMPACT:**

Amount: \$29,090.07

Funding Source: 2012-2013 CIP, Page Fire-4, Central Fire Station Replacement, FIR039

#### **ADDITIONAL INFORMATION:**

The construction of Fire Station No. 1 has been completed and is occupied by the Fire Department. The new facility replaces the existing facility at the Central Fire Station, 900 Mulberry, which is functionally obsolete and structurally in need of significant repairs. The new furnishings offer better ergonomic features and replace decade's old furniture.

The purchase and installation of the furnishings is being purchased from Pigott, Inc., 3815 Ingersoll Avenue, Des Moines, Iowa 50312, through the U.S. Communities Agreement.

Municipal Code section 2-726(f) provides for the procurement of goods and/or services from contracts that have been competitively established through the Western States Contracting Alliance and other cooperative contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division.
