### **AGENDA HEADING:**

Waiver of City's special assessments and inspection fees to allow for rehabilitation of the property at 1823 Clark Street by NFC Properties, LLC.

#### **SYNOPSIS:**

The NFC Properties, LLC has received the donation of a property at 1823 Clark Street, which is in need of rehabilitation. The waiver of City special assessments will lower the cost of rehabilitation and make the home more affordable for a homeowner. The NFC Properties, LLC is a non-profit development arm of the Neighborhood Finance Corporation (NFC), 1912 6<sup>th</sup> Avenue, Des Moines, IA 50314.

# **ADDITIONAL INFORMATION:**

NFC Properties, LLC is a development arm of the NFC. Holly Olson is the Executive Director. They are involved in rehabilitation and redevelopment of housing throughout the low- and moderate-income areas of the city.

A tax sale certificate buyer recently donated the house at 1823 Clark to the NFC Properties, LLC. A title search on the property revealed a number of special assessments from the City, Des Moines Water Works, and the Polk County Weed Commissioner. The house is located on a visible corner of 19<sup>th</sup> and Clark and its rehabilitation will improve the appearance of the corridor as well as provide an opportunity for affordable homeownership for a family.

NFC Properties, LLC will immediately begin clean-up of the exterior of the house and yard. Rehabilitation of the house will begin this summer. The NFC is also looking at acquiring an abandoned house at 1819 Clark Street, directly to the east of 1823 Clark. Unfortunately, that house is not a candidate for rehabilitation so the NFC is in the process of evaluating costs of acquisition, demolition, and possibly adding the lot at 1819 Clark to the house at 1823 Clark.

The NFC Properties, LLC currently has 1702 Forest Avenue under construction. The City Council waived special assessments for that property by Roll Call No. 12-0896 on June 11, 2012.
