#### **AGENDA HEADING:**

Resolution to appoint three members to the Des Moines Enterprise Zone Commission.

### **SYNOPSIS:**

Appointments to the Enterprise Zone Commission must be made pursuant to Iowa Code to continue the work of the Commission, which involves review of applications for the State of Iowa Enterprise Zone program within the City's seventeen recognized Enterprise Zones. This program is a special package of tax incentives designed to encourage reinvestment in economically distressed areas.
