AGENDA HEADING:

Authorization for the City Manager to release mortgage and related security instruments for Perry Wright, 3000 E Shawnee Avenue, Des Moines, Iowa 50317, 5(h) Affordable Homeownership Program.

SYNOPSIS:

Recommend Municipal Housing Governing Board approval for the Des Moines Municipal Housing Agency to reduce the term and release the second mortgage and security instruments for Perry Wright, 3000 E Shawnee Avenue, Des Moines, Iowa 50317.

FISCAL IMPACT:

Amount: \$50.00 processing fee for Second Mortgage term reduction.

Funding Source: 2012-2013 Operating Budget: Housing Services Department – Sec 5(h) Homeownership SP350 HSG021600, Page 139.

ADDITIONAL INFORMATION:

Perry Wright has successfully completed the program requirements of the Municipal Housing Agency’s 5(h) Affordable Homeownership Program and requirements for the early forgiveness of the term of the second mortgage. He currently has a seven year forgivable second mortgage in the amount of \$33,660 with the Des Moines Municipal Housing Agency. However, since he has lived in the home for more than seven (7) years and has completed program requirements, City Legal has prepared a Release and Satisfaction of the Second Mortgage and staff is requesting authorization to execute and record the document.

At the July 23, 2012, Municipal Housing Governing Board meeting by Roll Call No. 12-1141, the Board moved to refer to the City Manager to send a letter on behalf of the Council, to new owners, notifying them of City services and available programs.
