AGENDA HEADING:

Approving license to the Greater Des Moines Public Art Foundation for the installation, display and maintenance of glass mural on Court Avenue Storm Water Station and authorizing the Mayor to execute license agreement for same and to execute associated intellectual property agreements for glass mural and Dango sculptures at the Hub Spot.

SYNOPSIS:

Recommend approval of license agreement for installation, display and maintenance of glass mural on the Court Avenue pump station and intellectual property agreements for the glass mural and Dango sculptures at the Hub Spot.

Funding Source: The Greater Des Moines Public Art Foundation is responsible for the installation and maintenance of the glass mural.

ADDITIONAL INFORMATION:

The Greater Des Moines Public Art Foundation (“Foundation”) has proposed installing a fused glass mural titled “Expansion” by artist Jun Kaneko on the northern wall of the Court Avenue Stormwater Pump Station. There is currently a vinyl graphic of the proposed mural on the wall. The mural will be across the street from the previously placed Dango sculptures.

The mural will be owned and maintained by the Foundation. The design of the attachment to the City’s pump station has been provided by the Foundation. All work associated with the installation will be performed by a contractor hired by the Foundation.
