AGENDA HEADING:

Ordering construction of the following: East 14th Street & East Euclid Avenue Intersection Modification - Receiving bids, (5-7-13), and Setting date of hearing, (5-20-13). (Construction Estimate - \$186,500).

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. The project includes the removal of the existing island and reduction of the corresponding curb radius in the northeast corner of the intersection. The existing traffic signal pole will be relocated from the island to a location behind the new curb to provide sufficient clear zone and reduce the potential for collisions.

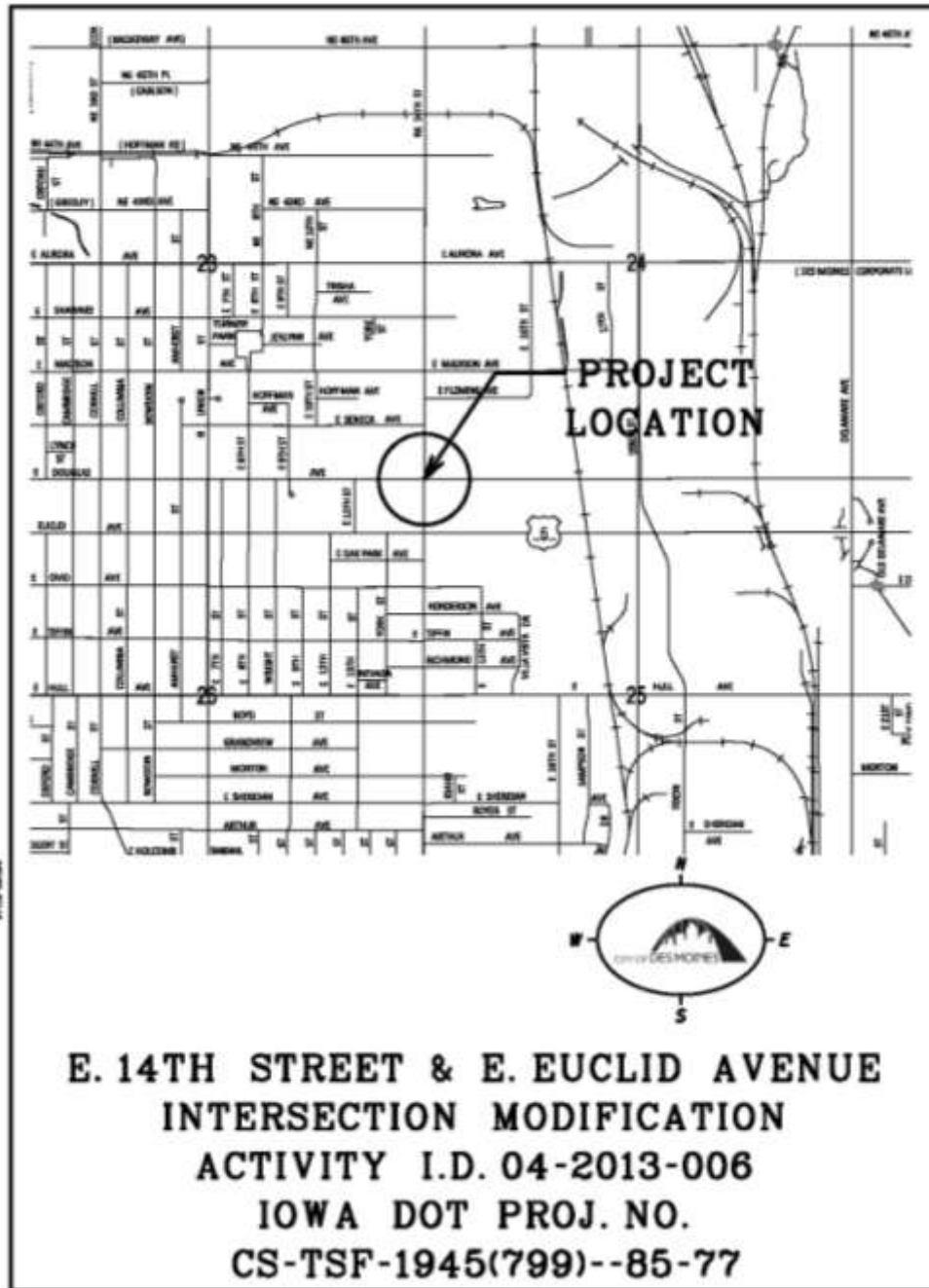

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the East 14th Street & East Euclid Avenue Intersection Modification, 04-2013-006. The improvement includes removal of roadway pavement, sidewalks, and existing traffic signals and replacement with new 10-inch Portland Cement Concrete (PCC) roadway pavement, Americans with Disabilities Act (ADA)-compliant sidewalk and curb ramps, traffic signals, and other incidental items in accordance with the contract documents, including Plans File Nos. 549-110/142, located at the intersection of East 14th Street (US Highway 69) and East Euclid Avenue (US Highway 6), Des Moines, Iowa.

The estimated construction cost is \$186,500. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
