SYNOPSIS:

Recommend approval of making appointment of the designated representative and alternate from the City of Des Moines to the Warren County E911 Joint Service Board.

ADDITIONAL INFORMATION:

Michele Bischof is the Superintendent of Technical Services for the Fire Department. As part of her responsibilities, she is a liaison between dispatch and fire operations. Communications Section Administrator Sandy Morris oversees administrative aspects of the Police and Fire Dispatch Center.

The Warren County E911 Joint Service Board exists to facilitate and coordinate the efforts of county and community governments in the processing of request for service through the 911 system. The mission of the Board is to plan, implement, manage, administer, and maintain an enhanced 911 telephone system in Warren County in accordance with Iowa Code, Chapter 34A and Administrative Rules 605, Chapter 10. This work is completed by the E911 Director as well as the Board itself.

Voting members of the Board are representatives from each political subdivision of the state having a public safety agency serving territory within the Warren County E911 Service Area. Members represent Carlisle, Des Moines, Hartford, Indianola, Lacona, Martensdale, Milo, New Virginia Township, Greenfield Township (Northern Warren), Norwalk, Pleasantville, Jackson Township, Warren County, West Des Moines, and Winterset.

The Board is financed by telephone exchange access line surcharge revenues that are made available through provisions of Chapter 34A, Code of Iowa, as authorized by the citizens of Warren County. In addition, the Board may make application to any federal or state agency for funding as well as establish agreements with local and private agencies for the purposes of administration of the Board and to carry out its purposes.
