AGENDA HEADING:

Hearing on E. 14th Street & E. Euclid Avenue Intersection Modification: Resolution approving plans, specifications, form of contract documents, engineer’s estimate, receive and file bids, and designating lowest responsible bidder as T K Concrete Inc., Tony J. Ver Meer, President, \$155,691.65.

SYNOPSIS:

This is a public hearing to allow for public input on the E. 14th Street & E. Euclid Avenue Intersection Modification and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes the removal of the existing island and reduction of the corresponding curb radius in the northeast corner of the intersection. The existing traffic signal pole will be relocated from the island to a location behind the new curb to provide sufficient clear zone and reduce the potential for collisions.

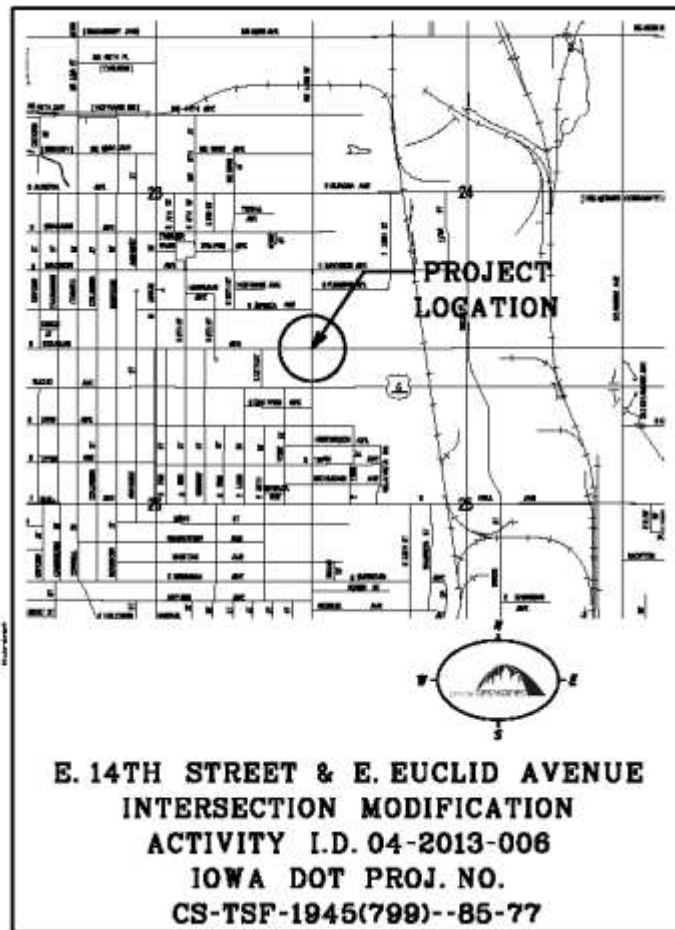
On April 22, 2013, under Roll Call No. 13-0625, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the E. 14th Street & E. Euclid Avenue Intersection Modification. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the E. 14th Street & E. Euclid Avenue Intersection Modification, 04-2013-006. The improvement includes removal of roadway pavement, sidewalks, and existing traffic signals and replacement with new 10-inch Portland Cement Concrete (PCC) roadway pavement, Americans with Disabilities Act (ADA)-compliant sidewalk and curb ramps, traffic signals, and other incidental items in accordance with the contract documents, including Plans File Nos. 549-110/142, located at the intersection of E. 14th Street (US Highway 69) and E. Euclid Avenue (US Highway 6), Des Moines, Iowa.

The Finance Director has determined that funds are available for said improvement as stated above.
