**T.M. Franklin Cownie, (R-9), Mayor,** to Louisville, Kentucky, from May 17 – May 20, 2013, (\$1,233.80) to attend the United States Conference of Mayors Compassion in Government meeting. The meeting will be a discussion of compassion and its role in the leadership of communities.

**T.M. Franklin Cownie**, (**R-9**), **Mayor**, to Denver, Colorado, from June 3 – June 7, 2013, (\$0) to attend the National Urban & Community Forestry Advisory Council meeting. Attendees will discuss best practices for the conversion and restoration of local forests in an effort to become more resilient to climate change while improving forest health, creating new jobs, and reconnecting citizens with their natural resources.

**Matt Porter**, (**NR-0**), **District Chief**, to Baltimore, Maryland, from June 5 – June 10, 2013, (\$1,360), to attend the IAFC International Hazardous Materials Response Teams conference. The conference will provide sessions that will increase knowledge of hazmat response and techniques which will enhance effective operational decision-making at emergency events.

The amended budget for travel and training in Fiscal Year (FY) 2013 is \$597,435. The amount expended for travel and training in FY 2013, as of May 13, 2013, is \$287,163.
