### **AGENDA HEADING:**

Hearing on First Amendment to Urban Renewal Plan for the Merle Hay Commercial Urban Renewal Area and adoption of same.

# **SYNOPSIS:**

This roll call closes the public hearing on the proposed First Amendment to the Merle Hay Commercial Urban Renewal Plan and approves the amendment. The proposed amendment updates the urban renewal plan with information, as required by state law, relating to the provision of tax increment financial assistance for specific projects approved by the City Council and updates the Financial Condition Report to include the proposed agreement with Merle Hay Mall Limited Partnership for the second phase of improvements to the Merle Hay Mall.

### **FISCAL IMPACT:**

Amount: There is no direct fiscal impact associated with the approval of the First Amendment. The public activities and projects that may be assisted by this urban renewal plan and tax increment revenues, subject to individual project approval, are now listed in the plan text as Appendix C.

Funding Source: Each project will/has a specific fund code assigned.

# **ADDITIONAL INFORMATION:**

More specifically, the proposed First Amendment to the Merle Hay Commercial Urban Renewal Plan:

- Approves the provision of financial assistance from tax increment revenues in the Merle Hay Commercial Urban Renewal Area for projects located at Merle Hay Mall Mall/Phase 1, 3801 Merle Hay Road and, as per preliminary terms of agreement for Merle Hay Mall/Phase 2 and includes these proposed projects in the newly-added Appendix C -- Approved Economic Development and Redevelopment Activities.
- Update the Financial Condition Report to reflect the projects that will be added to the listing contained in Appendix C.

Additional related actions relating to the First Amendment to the Merle Hay Commercial Area Urban Renewal Plan were undertaken as directed by the May 20, 2013 roll call that set the date of the public hearing:

- The required tax increment consultation meeting was held on May 30, 2013; as of June 17, 2013, no written comment has been received.
- The Urban Design Review Board reviewed the proposed amendment at its May 21, 2013 meeting and recommended approval.
