AGENDA HEADING:

Hearing on 2013 Sewer Repair - Contract 1: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, IA, 50047 in the amount of \$310,869.90.

SYNOPSIS:

This is a public hearing to allow for public input on the 2013 Sewer Repair - Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the replacement of storm sewers at two (2) locations: east of SW 39th Street and south of Welker Avenue where the storm sewer has been damaged by ongoing erosion and stream degradation and on Driftwood Avenue between Starview Street and Three Lakes Parkway where the storm sewer has been damaged by a landslide.


On June 10, 2013, under Roll Call No. 13-0877, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2013 Sewer Repair - Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2013 Sewer Repair - Contract 1, 08-2013-003. The improvement includes the construction of 18-inch, 24-inch, and 36-inch RCP storm sewer, intakes, manholes, stabilization of stream banks, and curb and gutter, seeding, sodding, and other incidental items; in accordance with the contract documents, including Plan File Nos. 553-099/115, at two (2) locations: SW 39th Street and Welker Avenue, and Driftwood Avenue from Star View Street to Three Lakes Parkway, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on July 2, 2013.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by The Underground Company, Ltd. in the amount of \$310,869.90 and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
