AGENDA HEADING:

Approving Change Order No. 6 with Jenco Construction, Inc. for additional work on the Grand Avenue Bridge Project, in an amount not to exceed \$175,000.

SYNOPSIS:

Recommend approval of Change Order No. 6 in an amount not to exceed \$175,000 with Jenco Construction, Inc., Herluf Jensen, President, 6804 NW 2nd Street, Des Moines, Iowa, 50313, to revise the bridge falsework design due to unforeseen site conditions pertaining to the presence of boulders and debris/obstructions encountered in the creek channel. This change order is necessary to preserve the current contractual intermediate completion dates and avoid additional delays.

FISCAL IMPACT:

ADDITIONAL INFORMATION:

Traditional concrete slab bridge construction relies on building temporary falsework underneath the proposed bridge to fully support the concrete slab bridge deck while the concrete is placed and is fully cured. The temporary falsework originally proposed is comprised of ten (10) rows of temporary timber pile supports that hold up a series of steel beams and timber joists that temporarily support the forms for the bridge deck.

During excavation and construction of the west abutment footing, pre-existing boulders and debris/obstructions were encountered in the upper soil layers in the creek channel. These obstructions were not encountered in the earlier soil borings. In planning for constructing the falsework, the proposed timber piles to support the falsework are likely to encounter similar conditions. The exact conditions and extent of the underlying obstructions were not and are not presently known, however based upon what has been discovered to date, it is likely extensive. Driving timber piles through this unknown layer could be very difficult with the obstructions present. If the ten row temporary support is constructed, then pursuant to the terms of the Iowa Department of Transportation (IDOT) contract and specifications, additional compensation would be required to excavate and remove the obstructions to facilitate placement of the timber falsework pile. In addition to the extra compensation, an extension of the intermediate completion dates would also need to be granted for the additional time consumed dealing with the unforeseen site conditions and obstructions.

Therefore, a new falsework design is proposed that would eliminate seven (7) of the ten (10) rows of temporary supports. Eliminating a majority of the temporary supports will add additional load on the remaining three (3) supports therefore requiring larger members. The three temporary supports will consist of steel piling that will be supported on a concrete footing. This revised arrangement eliminates any excavation that would be anticipated by obstructions encountered with driving timber falsework piling. In addition, this new design will be faster to construct and would not require extension of the completion dates. This change order compensates the contractor for the redesigned falsework and the larger steel members, and any work and time associated with construction of a three support system through the existing boulders and debris.
