# AGENDA HEADING:

Approving Supplemental Agreement No. 1 and Supplemental Agreement No. 2 to the Professional Services Agreement with Shuck Britson, Inc. to provide additional design and additional construction phase services for the Grand Avenue Bridge project.

#### SYNOPSIS:

Recommend approval to execute Supplemental Agreement No.1 to the Professional Services Agreement, as previously directed, with Shuck Britson, Inc., Tim Monson, President, 2409 Grand Avenue, Des Moines, Iowa, for a total cost not to exceed \$198,780.32, based on hourly rates, to provide additional design services, as directed by City Council, and approval of Supplemental Agreement No. 2 for a total cost not to exceed \$35,000, based on hourly rates, to provide additional construction phase services for the Grand Avenue Bridge Project.

## **ADDITIONAL INFORMATION:**

On August 29, 2011, by Roll Call No. 11-1528, City Council directed the City Engineer to pursue design of the project with one (1) turn lane and sidewalks on both the north and south sides of the new bridge with direction that the additional design effort not to exceed \$200,000. Supplemental Agreement No. 1 includes the design work required by this action. The actual cost of the redesign effort totals \$198,780.32. Supplemental Agreement No. 1 was not executed previously. This Council action executes the agreement that follows the direction given and allows payment to be made.

On July 29, 2013, by Roll Call No. 13-1187, City Council approved Change Order No. 6 with Jenco Construction, Inc. to revise the bridge falsework design. During excavation and construction of the west abutment, some debris and obstructions were encountered. It is likely these conditions would be encountered during construction of the original falsework design and the change order was necessary to preserve the current contractual intermediate completion dates and avoid additional delays. While the contractor is responsible for providing the design and construction of the new bridge falsework, additional construction administration services are also required for engineering design review of the new bridge falsework design and construction. Additionally, professional services are required to analyze the footing design due to the contractor's placement of the piles that differ from the contract

documents and to develop a solution for the contractor's consideration in correcting the work. Supplemental Agreement No. 2 includes additional construction administration services to review the new bridge falsework design and analyze the footing design. Staff has negotiated Supplemental Agreement No. 2 with Shuck Britson, Inc., for a total cost not to exceed \$35,000, based on hourly rates, to provide the required additional construction administration services for the Grand Avenue Bridge project.
