### **AGENDA HEADING:**

Approval of Grant Agreements with the U.S. Department of Housing and Urban Development (HUD) for funding of the City's Fourth Year (2013) Action Plan of the 2010-2014 HUD Consolidated Plan.

#### **SYNOPSIS:**

Recommend Council approval of grant agreements by and between HUD and the City of Des Moines, whereby the City will receive Community Development Block Grant (CDBG), HOME Investment Partnership program (HOME), and Emergency Solutions Grant (ESG) funding (grant awards) for the implementation of the Fourth Year (period of January 1, 2013 to December 31, 2013) Action Plan of the 2010- 2014 HUD Consolidated Plan.

## **ADDITIONAL INFORMATION:**

At the City Council meeting on November 5, 2012, the Council approved the Fourth (2013) Year Action Plan of the 2010-2014 HUD Consolidated Plan consisting of CDBG, HOME, and ESG funding. From 2012 to 2013, funding for CDBG has increased by \$179,863; funding for HOME has increased by \$30,768; and funding for ESG decreased by \$89,439. In order to receive HUD draw downs we have to process the Grant Agreements.
