## **AGENDA HEADING:**

### ADDITIONAL INFORMATION:

Kimberly A. Ross (n/k/a Kimberly A. Tenborg) has successfully completed the program requirements of the Municipal Housing Agency's 5(h) Affordable Homeownership Program and requirements for the early forgiveness of the term of the second mortgage. She currently has a seven (7) year forgivable second mortgage in the amount of \$29,040 with the Des Moines Municipal Housing Agency. However, since she has lived in the home for more than seven (7) years and has completed program requirements, City Legal has prepared a Release and Satisfaction of the Second Mortgage and staff is requesting authorization to execute and record the document.

At the July 23, 2012 Municipal Housing Governing Board meeting the Board suggested letters be sent on behalf of the City Council to new owners notifying them of City services and available programs. A letter will be sent.
