AGENDA HEADING:

Authorization to proceed with acquisition of the necessary right-of-way and easements for the East 4th Street at Walnut Street and Court Avenue Traffic Signal Project by gift, negotiation, or condemnation.

SYNOPSIS:

Recommend authorization to acquire the necessary right-of-way and easements for the East 4th Street at Walnut Street and Court Avenue Traffic Signal Project by gift, negotiation, or condemnation. Iowa law requires this action before the City can initiate the right-of-way acquisition process under eminent domain.

FISCAL IMPACT:


Amount: \$5,000 total estimated right-of-way acquisition and closing costs.

<u>Funding Source</u>: 2013-14 CIP, Page Street Improvements – 46, TR091, Traffic Signals, Channelization, and School Crossings

ADDITIONAL INFORMATION:

This project includes installation of new traffic signals at the intersections of East 4th Street and Walnut Street and East 4th Street and Court Avenue. The project also includes widening Walnut Street east of East 4th Street along the north side of the roadway. The pedestrian ramps will be reconstructed at all four (4) corners of each intersection.

One (1) partial fee acquisition and one (1) temporary construction easement will be required for construction of this project. These acquisitions will not require relocation assistance.
