AGENDA HEADING:

Approving Articles of Agreement for Sub-Grant # EMW-2013-SS-00004-S01 (Cyber Risk Reduction) with the Iowa Homeland Security and Emergency Management Division.

SYNOPSIS:

Recommend approval of the Federal Fiscal Year (FFY) 2013 Homeland Security Grant Program (HSGP) Agreements. The Iowa Homeland Security and Emergency Management Director has requested the City of Des Moines serve as fiscal agent for the administration of Iowa’s FFY 2010 Homeland Security Grant Program. This agreement provides federal grant funding assistance to City of Des Moines and the Iowa Department of Administrative Services on behalf of Cyber Risk Reduction Phase 4, under the FFY 2013 HSGP, to develop a system to provide automated network and web application vulnerability scanning capabilities.

FISCAL IMPACT:

Amount: \$505,591

Funding Source: U.S. Department of Homeland Security (DHS), Grant Programs Directorate, FFY 2013 HSGP. There is no local match required for the grant.

ADDITIONAL INFORMATION:

To the extent modified above, under the Grant Agreement, the City of Des Moines remains a participant and a beneficiary of the overall project and will incur no costs. This allows the City of Des Moines to take advantage of software developed under this grant to identify cyber risks and vulnerabilities to the city network and provide cross collaboration with other state agencies to determine risk identification.
