AGENDA HEADING:

Hearing for the vacation and conveyance of the north 20 feet of Railroad Avenue right-of-way adjoining 918 SE 11th Street to Youth Emergency Services and Shelter (YESS) for \$6,000.

SYNOPSIS:

Recommend approval of the vacation and conveyance of the north 20 feet of Railroad Avenue right-of-way adjoining 918 SE 11th Street to YESS, Stephen Quirk, Officer, 918 SE 11th Street, Des Moines, Iowa, 50309, for \$6,000. This action is required by Iowa law prior to making a final determination on the proposed vacation and sale by resolution.

The buyer will incorporate the North 20 feet of Railroad Avenue right-of-way into its larger parcel to allow for the construction of a two-story, 9,000 square foot addition to the existing youth emergency shelter, and to meet required setback requirements for the addition. There is no current or anticipated public need for this property and the sale of the property will help reduce the City's ownership of excess land.



ADDITIONAL INFORMATION:

YESS is a private nonprofit organization serving children and their families in Central Iowa. YESS is the owner of the youth emergency shelter located at 918 SE 11th Street and has agreed to purchase the North 20 feet of Railroad Avenue right-of-way that adjoins their property for \$6,000. The property to be conveyed consists of approximately 4,000 square feet, and the purchase price of \$6,000 is equal to the estimated fair market value of the property as determined by the City's Real Estate Division. There is no current or anticipated public need for this property, and the City's conveyance of this property will allow the buyer to construct the addition to the existing building thereby increasing the number of youth the shelter can serve by 27 for a total of 99.
