# **ADDITIONAL INFORMATION:**

This proposed subdivision plat contains 34 row house residential lots on a 1.8 acre downtown infill tract of land.

The subject site is located at the northeast corner of the intersection of SW 7th Street and Tuttle Street. The subdivision contains six (6) four-unit and two (2) five-unit two-story buildings. All new units will contain two (2) car garage spaces accessed by the public alley and private internal drives. The private drives used for access into this development and a central green space will be owned and maintained by a private association. Each unit will have a rooftop garden/patio space with pergola. Each unit is to be three (3) bedrooms with a total of 1,350 square feet.
