AGENDA HEADING:

Approving Change Order No. 1 with Edge Commercial, LLC, for additional work on the Police Department Evidence Storage Facility – Phase II, in an amount not to exceed \$58,254.

SYNOPSIS:

Recommend approval of Change Order No. 1 in an amount not to exceed \$58,254 with Edge Commercial, LLC, Jason Ceretti, Partner, 3155 SE Miehe Drive, Suite 2, Grimes, Iowa 50111, for additional work on the Police Department Evidence Storage Facility – Phase II.

FISCAL IMPACT:

Amount: \$58,254

<u>Funding Source</u>: 2013-2014 CIP, Page Building – 13, Police Station Improvements – Phase II, BL125, Being: \$725,000 G.O. Bonds issued, \$660,200 of Automated Traffic Enforcement revenue, and \$75,000 transfer from \$324 PD226000 – Forfeited Funds.

ADDITIONAL INFORMATION:

On June 24, 2013, by Roll Call No. 13-1057, the City Council awarded a construction contract in the amount of \$1,460,200 to Edge Commercial, LLC for the Police Department Evidence Storage Facility – Phase II. At the time the contract was awarded, the St. Louis jail cell space was designated to be converted to office space. After construction work had commenced, the Police Department was notified that they had been awarded the 2013 Justice Assistance Grant. On September 23, 2013, by Roll Call No. 13-1491, the City Council voted to accept the grant award. Once the grant funding was secured, the needs of the department were evaluated resulting in the determination to repurpose the jail cell space into an evidence processing laboratory for processing blood related and trace evidence such as fingerprints. Change Order No. 1 will provide for room finish upgrades from the originally bid office finishes to new laboratory finishes as well as enhanced ventilation and lighting systems to support these forensic activities.
