AGENDA HEADING:

Approving agreement to transfer Iowa Homeland Security and Emergency Management Division (IHSEMD) for cyber risk reduction grant to Iowa Department of Administrative Services (IDAS).

SYNOPSIS:

This action will approve the agreement to transfer IHSEMD for cyber risk reduction grant to the IDAS for implementation of grant responsibilities, authorizes the Information Technology (IT) Director to execute implementing agreements with IDAS, and authorizes the transfer of grant funds to IDAS in accordance with the agreement.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

The U.S. Department of Homeland Security allocated funds to states and local governments through the federal Homeland Security Grant Program for approved initiatives supporting national priorities and state strategies directed toward prevention, response, mitigation and recovery efforts related to terrorist attacks. On September 23, 2013, by Roll Call No. 13-1489, the City Council approved the IHSEMD award to the City of a grant in the amount of \$505,591 and a 2013 Homeland Security Grant Program Commitment to award and accept fund grant agreement between IHSEMD and the City of Des Moines to perform work supporting Cyber Risk Reduction Phase 4 under the Initial Strategy Implementation Plan developed by IHSEMD, (Grant # EMW-2013-SS-0004-S01), (2013 Grant Agreement). The IDAS and City Information Technology staff have negotiated a Memorandum of Agreement whereby the 2013 grant funds will be transferred to IDAS and IDAS will be responsible for implementation of the 2013 Grant Agreement objectives (IDAS Agreement), a copy of which is on file in the City Clerk’s Office.
