AGENDA HEADING:

Approval to purchase eight (8) in-car cameras and associated equipment from COBAN Technologies Incorporated, 12503 Exchange Drive, Suite 536, Stafford, Texas 77477, Allan Chen, President.

SYNOPSIS:

Recommend approval to purchase of eight (8) additional camera units to be installed in eight (8) marked patrol vehicles. On June 28, 2010, the City Council approved the purchase of an in-car video system from COBAN Technologies Incorporated on Roll Call No. 10-1042. This highly specialized system has been installed and is currently operational. The Patrol Bureau has been impressed with the operational capabilities of this system and desires to expand the number of patrol cars which can utilize the equipment on a daily basis.

ADDITIONAL INFORMATION:

The COBAN System is a productive method to document investigations and probable cause needs. It also meets the requirements of custody interviews, and provides recorded happenings at crime scenes and other police activities. The system is an efficient means of reproducing audio/video evidence for criminal prosecutions.

The camera units requested are compatible with the current software and connectivity inherent to the COBAN System. Municipal Code section 2-726 (a)(7) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective. This is also used as a form of standardization of the equipment for the benefit of the officers as well as the maintenance of the equipment. We currently have ongoing maintenance and support agreements with COBAN as well.

The Police Department recommends the purchase of these eight (8) units from COBAN Technologies to enhance our current system.
